Ordinance No. 7, s. 2005

AN ORDINANCE ORDAINING A TOTAL BAN ON THE USE OF FIRECRACKERS AND OTHER FORMS OF EXPLOSIVES DURING CHRISTMAS SEASON IN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR AND PROVIDING PENALTIES IN CASE OF VIOLATION HEREOF.

WHEREAS, one of the common festive way of celebrating yuletide or Christmas season is the use of firecrackers and other forms of explosives to mention a few such as bawang, superlolo and whistle bombs which is uncontrolled and uninterrupted until at present;

WHEREAS, the continuous use of these materials and the damaging effects of the sounds of firecrackers cause and create noise, disturbance and fear to small children and peace-loving citizens of the community;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan in session assembled that:

SECTION 1. TITLE. This ordinance shall be called, "An ordinance ordaining a total ban on the use of firecrackers and other forms of explosives during Christmas season in the municipality of Dumingag, Zamboanga del Sur and providing penalties in case of violation hereof."

SECTION 2. REGULATORY/PROHIBITIVE PROVISION. No person or persons shall use or engage in the use of firecrackers and other forms of explosives to mention a few such as bawang, superlolo, whistle bombs, triangles, kwitis and the like during Christmas or yuletide season specifically from November 18 to January 6 of the succeeding year.

SECTION 3. PENAL PROVISION. Any person or persons found violating the provisions of this ordinance shall be fined in the amount of five hundred (P500) pesos for the first commission, one thousand (P1,000) pesos for the second commission and two thousand (P2,000) pesos for the third and succeeding violations and imprisonment of thirty (30) days or one month to six (6) months upon the discretion of the competent court.

SECTION 4. AMENDATORY CLAUSE. All existing laws, ordinances, resolutions, and executive orders found in conflict with this ordinance shall be deemed and considered modified and amended accordingly.

SECTION 5. EFFECTIVITY CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and at least two (2) other conspicuous places in the Poblacion and publication in the newspaper of general circulation.
