ORDINANCE NO. 7, s. 1998

" AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 14, s. 1997 is
ENTITLED AN ORDINANCE REGULATING THE OPERATION OF FLYING OR
MOTORIZED AND MARKET FISH VENDORS IN THIS MUNICIPALITY AND
PROVIDING PENALTY THEREOF."

Be it enacted by the Sangguniang Bayan of Dumanigag, Zamboanga del Sur
in session assembled, that :

Section 1. Section 1 of Municipal Ordinance No. 14, s. 1997 is hereby
amended by substitution, to read as follows :

Section 1. TITLE - This Ordinance shall be called "AN ORDINANCE REGU-
LATING THE OPERATIONS OF FLYING OR MOTORIZED AND MARKET FISH
VENDORS AND PROVIDING PENALTIES FOR VIOLATION THEREOF."

Section 2 . Section 2 of Municipal Ordinance No. 14, s. 1997 is hereby
amended by adding paragraph e, to read as follows :

Section 2. DEFINITION OF TERMS

e) POBLACION - under this Ordinance, the poblacion shall
comprise the two (2) Barangays San Pedro and San Pablo
including sitio kalubihan, kurbada and Western Mindanao
Academy.

Section 3. Section 3 of Municipal Ordinance No. 14, s. 1997 is hereby
amended substitution, insertion or addition of provisions,
to read as follows :

Section 3. NUMBER AND COLOR CODING SYSTEM - There is hereby required a
number and color coding system for all boxes of flying or
motorized fresh fish vendors for proper identification. Fish
boxes must be painted with colors and corresponding code
numbers, as herein provided :

a) FOR INSIDERS -YELLOW COLOR with the corresponding code
numbers of three (3) digits in blue color that begins with

Two Hundred (200) and the succeeding numbers shall start to count right i.e. 201, 202, 203, 204 and upward.

- b) FOR OUTSIDERS FROM SINDANGAN AND/OR SOUTHWESTERN PART - BLUE COLOR with the corresponding code numbers of three (3) digits in yellow color that begins with Four Hundred (400) and the succeeding numbers shall start to count right i.e. 401, 402, 403, 404 and upward.
- c) FOR OUTSIDERS FROM PLACES LIKE PAGADIAN CITY, TUKURAN, TANGUB CITY AND/OR SOUTHWESTERN PART -RED COLOR with the corresponding code numbers of three (3) digits in black color that begins with Eight Hundred (800) and the succeeding numbers shall start to count right i.e. 801, 802, 803, 804 and upward.

Section 4. Section 4 of Municipal Ordinance No. 14, 1997 is hereby amended by addition of provisions, to read as follows :

Section 4. TRANSPORT PERMIT - There is hereby mandated Annual Transport Permit for all flying or motorized fish vendors to be issued by the Municipal Mayor, upon payment of the required transport permit fee of FIFTY PESOS (P50.00) per travelling unit to the office of the municipal treasurer. Under such permit, all flying or motorized fish vendors are only permitted to sell in mobile strictly on areas outside the poblacion herein specified. Consumers within the poblacion are considered major customers of the market fish vendors.

Section 5. Section 5 of Municipal Ordinances No. 14, s. 1997 is hereby amended, to read as follows :

Section 5. POLICIES FOR FLYING OR MOTORIZED AND MARKET FISH VENDORS - No insiders or outsiders and market fish vendors shall be allowed to operate business/sell fish without compliance with the necessary tax payment as provided for in the Municipal Revenue Code of 1994 and the regulatory provisions herein mandated. All market fish vendors are enjoined to maintain cleanliness within their respective premises.

Section 6. Section 6 of Municipal Ordinance No. 14, s. 1997 is hereby amended by substitution of the entire provisions of the section, to read as follows :

Section 6. PENAL PROVISIONS - Any person found guilty of violating the provisions of this Ordinance shall be penalized accordingly :

- a) First Offense - a fixed fine of FIVE HUNDRED PESOS (P500.00) or imprisonment of one (1) week or both at the discretion of the court.
- b) Second Offense - a fixed fine of SEVEN HUNDRED PESOS (P700.00) or imprisonment of two (2) weeks or both at the discretion of the court.
- c) Third Offense - a fixed fine of ONE THOUSAND PESOS (P1,000.00) and revocation of "Business Permit" including "Transport Permit" for the flying or motorized fish vendors.

Section 7. The number of the succeeding Sections of the Municipal Ordinance No. 14, s. 1997 shall condone respectively, as to :

Section 7. IMPLEMENTING RULES

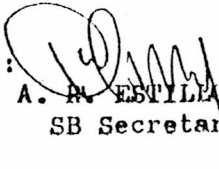
Section 8. REPEALING CLAUSE

Section 9. SEPARABILITY CLAUSE

Section 10. EFFECTIVITY - This Ordinance shall be enforceable upon approval by the Sangguniang Panlalawigan and after fifteen (15) days from its publication at the entrance of the municipal hall.

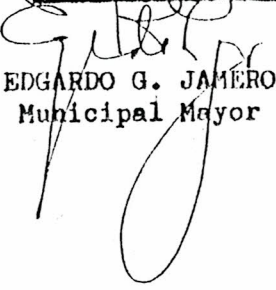
