ORDINANCE NO. 8, S. 1995

AN ORDINANCE PRESCRIBING POLICIES AND GUIDELINES FOR PROPER AND SAFETY DRIVING OF TRI-SIKAD AND IMPOSING FINES/PENALTIES FOR VIOLATION THEREOF. AUTHORED BY KAGAWAD GEOGRAPHIA, CO-AUTHOR- KAGAWAD INOCENCIO FAUNILLAN.

Be it enacted by the Sangguniang Bayan of Dumingag, Zamboanga del Sur, in session assembled :

ARTICLE I - PURPOSE

Section 1 - The objective of prescribing policies and guidelines is to produce responsible and courteous drivers, for proper identification and safety driving of a public utility vehicle, the tri-sikad.

ARTICLE II - IDENTIFICATION OF TERMS

Section 1 - In support to the interpretation of any provision of this Ordinance, hereunder are the following terms to be considered:

- A. Tri-Sikad - a public utility vehicle legally owned by a person with painted number in front and back views thereof.
- B. Operator - a tri-sikad owner holding a franchise to operate granted by the government.
- C. Driver - any licensed individual driving a tri-sikad, serving the public.
- D. ID Card - Identification card issued by the government which driver shall bear while driving.
- E. Lamp - A kerosene lamp or any kind of lamp on tri-sikad for dark time.
- F. PNP - Philippine National Police Municipal Station.

ARTICLE III - POLICIES AND GUIDELINES

Section 1. Any renewing and/or new applicant for driver's license shall pass an orientation seminar prior to the issuance of such license, to be conducted by the PNP in coordination with the Office of the Municipal Mayor, Committee on Public Utilities and Transportation of the Sangguniang Bayan and the Office of the Municipal Treasurer.

Section 2. The Office of the Municipal Mayor shall issue an ID Card to all qualified applicants for driver's license by which such ID Card shall be prepared by the Office of the Municipal Treasurer. Signatories of such ID Card's shall be

portation of t Sanguniang Bayan and the Chief of Police concerned.

Section 3. No person shall be granted with driver's license who is below fifteen (15) years of age. Driving without license is absolutely prohibited.

Section 4. Any driver shall not be allowed to drive a tri-sikad without bearing on display the ID card issued to him by the government.

Section 5. The driver shall not select, discriminate and/or refuse to convey a riding individuals to any point of poblacion and route area within the municipality without valid reasons. If having valid reason/s, the driver shall properly and courteously explain to the riding individual/s for the benefit of the franchise and license to operate and drive, respectively granted by the government.

Section 6. Any operator shall be required to put up a lamp in front view of tri-sikad while operation during dark time from 6:00 P. M. until 5:00 o'clock dawn. Any driver shall not be allowed to drive in the absence of such lamp.

ARTICLE IV - INTERPRETATION AND ENFORCEMENT

Section 1. In case of confusing provision of this Ordinance, the definition of terms shall be referred to.

Section 2. The PNP shall strictly enforce this Ordinance at all times.

ARTICLE V - FINES AND PENALTIES

Section 1. Any tri-sikad driver or individual who fully violates any provision of this ordinance shall be fined/penalized as follows :

| A. 1st Offense | = P50.00 or Six (6) hours imprisonment |
| B. 2nd Offense | = P100.00 or twelve (12) hours imprisonment |
| C. 3rd Offense | = P300.00 or eighteen (18) hours imprisonment or both at the discretion of the court. |

ARTICLE VI. EFFECTIVITY

Section 1. This ordinance shall take effect after the review by the Sanguniang Panlalawigan and 15 days posting in all conspicuous places of this municipality and all ordinances, resolutions or laws of local effect inconsistent with this Ordinance are hereby modified, superseded or repealed accordingly.
