Ordinance No. 8, s. 2000

“AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 4, S. 2000 ENTITLED “AN ORDINANCE PROVIDING INSURANCE COVERAGE TO BANTAY BAYAN MEMBERS IN EVERY BARANGAY WITHIN THE MUNICIPALITY, PRESCRIBING RULES AND MECHANICS FOR ITS EFFECTIVE IMPLEMENTATION AND APPROPRIATING FUNDS THEREFORE.”

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur, in session assembled that:

Section 1. Section 6 of Municipal Ordinance No. 4, s. 2000 is hereby amended by adding two (2) requirements in par. (b) and by adding paragraphs (d) and (e) for consistent provisions.

SECTION 6. REGULATORY PROVISIONS - There is hereby granted a Life Insurance Coverage by the Local Government Unit (LGU) of Dumingag, Zamboanga del Sur to all Bantay Bayan Members with rules and mechanics for its effective implementation.

(b) The Insurance Coverage of the Bantay Bayan Members will be claimed and received by the Member/Beneficiary from the municipal government, provided, however, that requirements are complied and submitted to the Office of the Municipal Mayor, to wit :

1. Punong Barangay Certification stating thereon the occurrence and nature of incident to include whether the Bantay Bayan concerned was on duty or not ;
2. Police Report
3. Medical Certification duly signed by the attending physician of the hospital/clinic being confined by the Bantay B concerned ;
4. Death Certification from the LCR office (In case of death) ;
5. Proof of Membership to Bantay Bayan ;
6. Application Form from the Office of the Municipal Mayor, duly filled in by the Bantay Bayan Member concerned or his beneficiary/claimant, recommended by the Punong Barangay and approved by the Municipal Mayor ;
7. SB resolution appropriating for such amount ; and
8. Proper voucher duly signed by all concerned for issuance of check to be withdrawn from the bank which funds for Insurance Coverage of Bantay Bayan are being deposited.

(d) The cash assistance specified in No. 1, Par. (a) of this Section is maximum. Upon appropriation by the Sangguniang Bayan as required under No. 7, Par. (b) hereof, the amount shall depend upon the degree of physical injury of the Bantay Bayan Member concerned.

- (e) The Office of the Municipal Mayor shall produce the Application Forms, to be properly filled in by the claimant (Member or Beneficiary) for cash assistance and/or insurance benefits granted under this Ordinance.

Section 2. Section 7 of Municipal Ordinance No. 4, s. 2000 is hereby amended, to read as follows :

SECTION 7. APPROPRIATION - There is hereby appropriated an amount of TWO HUNDRED THOUSAND PESOS (P200,000.00), as incorporated in the Annual Budget for CY 2000 under Appropriation Ordinance No. 42, s. 1999, particularly at the Twenty Percent (20%) EDF. The amount mentioned herein must be reflected every year in the Annual Budget particularly in the General Appropriation, to be prepared by the Municipal Budget Officer for Bantay Bayan Members Insurance Coverage.

Section 3. SEPARABILITY CLAUSE - If any apart or provision of this Ordinance may be declared invalid or unconstitutional, the remaining portion not affected by such declaration shall remain to be in full force and effect.

Section 4. EFFECTIVITY CLAUSE - This Ordinance shall take effect upon its approval.

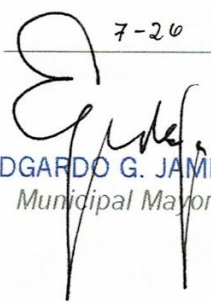
