ORDINANCE NO. 9, s. 1998

" AN ORDINANCE MANDATING THE MUNICIPAL MAYOR TO RENDER ACCOMPLISHMENT REPORTS TO THE PUBLIC WHICH INCLUDES AWARDED PLAQUE OF APPRECIATION AND CITATION, AND TO GIVE CERTIFICATE OF COMMENDATION TO DESERVING GOVERNMENT EMPLOYEES "

WHEREAS, in line with the vision of the new administration, headed by Hon. Edgardo G. Jamero, municipal mayor;

WHEREAS, in order to pursue a positive change of Dumingag into a politically, socially and economically developed municipality, thus, making it a better and happy place to live in;

WHEREAS, the proponent, Hon. Morpos wishes to give credence to the populace by letting them know the activities going on in the different administrative unit of our local government;

NOW, THEREFORE, this august body hereby adopts as it is hereby adopted, that a yearly reporting is necessary.

BE IT ORDAINED by this august council of the Municipality of Dumingag, that;

SECTION I - There will be a program prepared under the direction of the municipal mayor of the December activity to commence this year 1998.

SECTION II - That a committee is to be organized from a chosen personnel to determine the yearly government employee awardees.

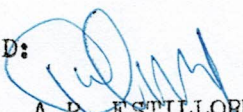
SECTION III - That executive order be promulgated relevant to this effect.

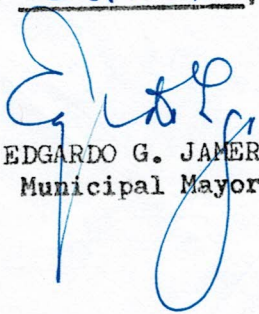
