Municipal Ordinance No. 10, s. 2015

AN ORDINANCE FIXING RATE FOR THE MAINTENANCE FEE OF THE LGU VEHICLES OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.

Be it enacted by the Sangguniang Bayan in session assembled that:

Section 1. TITLE.

This ordinance shall be called "Ordinance fixing rate for the maintenance fee of the LGU vehicles of the municipality of Dumingag, Zamboanga del Sur.

Section 2. FEES.

There shall be imposed a maintenance fee of LGU vehicles in the following breakdown:

2.1. Maintenance fee

VEHICLE	RATE/DAY
Giant Jeep/truck/fighter	One Thousand Five Hundred Pesos (P1,500.00) excluding fuel & oil
Military Jeep/Small Jeep	Five Hundred Pesos (P500.00) excluding fuel & oil
Mini Dumptruck	One Thousand Pesos (P1,000.00) excluding fuel & oil
Kumong-kumong	One Thousand Pesos (P1,000.00) excluding fuel & oil

2.2. Fuel - fuel shall be shouldered by the user and shall be determined by distance travelled.

2.3. Discounts

2.2.a. LGU employees 20% discount

2.2.b. Barangay Officials 20% discount

2.2.c. Barangay government use 25% discount

2.4. Exemption to maintenance fee

a. Usage for carrying patient and dead person is free of charge.

Section 3. IMPLEMENTING RULES & REGULATIONS.

The Municipal Mayor through the recommendation of the Municipal Treasurer shall formulate an implementing guidelines for proper implementation of this ordinance.

Section 4. SEPARABILITY CLAUSE.

For any reason, a portion of this ordinance is declared null and void, the rest of the portion thereof not affected by such declaration shall be in effect and subsisting.

Section 5. EFFECTIVITY CLAUSE.

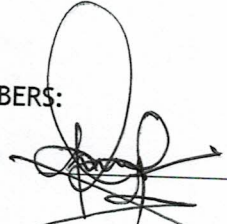
