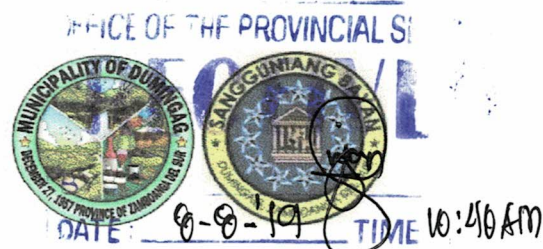

Municipal Ordinance No. 10, s. 2019

AN ORDINANCE CREATING A POSITION OF BOOKBINDER IV (SG-10) IN THE OFFICE OF THE MUNICIPAL MAYOR IN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR AND PROVIDING FUNDS THEREFOR.

Be it ordained by the Sangguniang Bayan in session assembled that:

Section 1. TITLE.

This ordinance shall be called “An ordinance creating a position of Bookbinder IV (SG-10) in the Office of the Municipal Mayor in the municipality of Dumingag, Zamboanga del Sur and providing funds therefor.”

Section 2. CREATION.

The position of Bookbinder IV is hereby created in the Office of the Municipal Mayor which shall be included in the plantilla of personnel of the Local Government of Dumingag, Zamboanga del Sur.

Section 3. SALARY GRADE.

The created position has a salary grade of SG-10 pursuant to Civil Service Qualification Standard and other pertinent laws, rules and regulations.

Section 4. APPROPRIATION.

The Municipal Budget Office shall prepare corresponding budget to cover outlay for the salaries and other emulations due to the creation of position as provided for in Section 2. Therefore as well as mandatory and statutory obligation to be shouldered by the Municipal Government in which this shall be reflected every year in the executive annual budget.

Section 5. SEPARABILITY CLAUSE.

Any section or provision in this ordinance maybe declared unlawful or invalid the remainder of such declarations shall remain to be in full force and effect.

Section 6. EFFECTIVITY CLAUSE.

This ordinance shall take effect upon its approval.

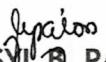
