Municipal Ordinance No. 14, 2014

AN ORDINANCE CREATING THE POSITION OF ONE (1) COMMUNITY AFFAIRS OFFICER II IN THE OFFICE OF THE MUNICIPAL MAYOR, DUMINGAG, ZAMBOANGA DEL SUR.

Be it enacted by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled that:

Section 1. TITLE. This ordinance shall be called, "AN ORDINANCE CREATING THE POSITION OF ONE (1) COMMUNITY AFFAIRS OFFICER II, FROM THE OFFICE OF THE MUNICIPAL MAYOR.

Section 2. CREATION. There is hereby created position of 1 Community Affairs Officer II to be included in the plantilla of personnel of the Local Government Unit (LGU) of Dumingag, Zamboanga del Sur under the Office of the Municipal Mayor.

Section 3. SALARY GRADE. The salary grade of Community Affairs Officer II shall be salary grade 15.

Section 4. APPROPRIATION. The annual salary and other emoluments due for the created position shall be P350,890.72 which shall be reflected every year in the executive budget as well as mandatory and statutory obligations to be shouldered by the municipal government.

Section 5. SEPARABILITY CLAUSE. Any section or provision of this ordinance which may be declared unlawful or invalid, the remainder of such declarations shall remain to be in full force and effect.

Section 6. EFFECTIVITY. This ordinance shall take effect after review by the Sangguniang Panlalawigan.

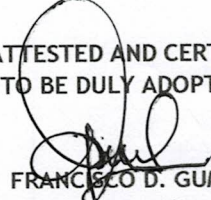

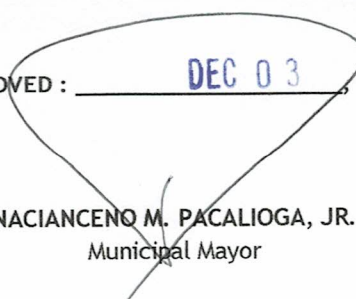
