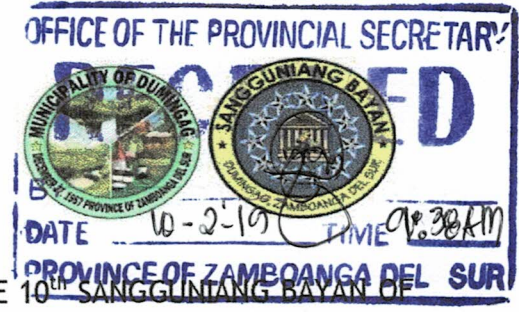

Municipal Ordinance No. 15, s. 2019

AN ORDINANCE DECLARING SEPTEMBER 9-15 OF EVERY YEAR AS TRANSFORMATIVE EDUCATION WEEK WITHIN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.

Be it ordained by the Sangguniang bayan in session assembled that:

Section 1. TITLE.

An ordinance declaring September 9-15 of every year as Transformative Education Week within the municipality of Dumingag, Zamboanga del Sur.

Section 2. SCOPE.

This ordinance shall apply within the Municipality of Dumingag, Zamboanga del Sur.

Section 3. RATIONALE.

Transformative Education is a contextualized, responsive and a Genuine Educational System that is appropriate to the real condition. It transforms education into more comprehensive, genuine meaningful and realistic face as it was being unbinden from the concrete and true manifestation of life for a long time.

It is an Education System that changes the hearts and minds of the people into progressive and advanced societal system and culture that is anchored to the sustainable organic agriculture, indigenous peoples and core values of the people of Dumingag.

In line with this, this ordinance is created declaring September 9-15 of every year as transformative education week within the municipality of Dumingag, Zamboanga del Sur. This is necessary in order to realize the dream to attain the kind of education wanted for the people.

Section 4. PURPOSE.

This ordinance is enacted purposely in order to:

1. Declare September 9-15 of every year as Transformative Education Week in the municipality of Dumingag, Zamboanga del Sur.

2. Develop and strengthen knowledge and skills in sustainable organic agriculture, Indigenous People Education (IPEd) and Integrative health and medicine from organic farmers, Subanen Lumads and teachers.
3. Serve as a learning environment to deepen and accumulate learnings about transformative education.
4. Raise awareness and capability of all the people in Dumingag in disaster risk reduction and management, climate change adaptation and solid waste management.
5. Serves as a learning platform for Indigenous Peoples (IP) culture understanding and promote, develop social enterprise in communities.
6. Recognize, value and respect the municipality's achievements in terms of transformative education.

Section 6. ACTIVITIES.

Activities during the week-long celebration shall include but not limited to the following:

Section 7. LOCAL TEACHER'S DAY CELEBRATION.

There shall be a Local Teacher's Day Celebration within the week which shall be determined by the implementing office.

Section 8. IMPLEMENTING OFFICE.

The Municipal Mayor's Office shall be the implementing office of this ordinance.

Section 9. SEPARABILITY CLAUSE.

If any portion or section of this ordinance is declared void or unconstitutional, the remaining portions thereof shall be in full force and effect.

Section 10. EFFECTIVITY AND PUBLICATION CLAUSE.

This ordinance shall take effect immediately upon its approval.
