Municipal Ordinance No. 24, s. 2019

AN ORDINANCE DECLARING THE SECOND WEEK OF AUGUST OF EVERY YEAR AS LINGGO NG KABATAAN IN THE MUNICIPALITY OF DUMINGAG ZAMBOANGA DEL SUR AND PROVIDING FUNDS FOR THE IMPLEMENTATION THEREOF.

Section 1. TITLE.

This ordinance shall be known as “*Linggo ng Kabataan*” in the Municipality of Dumingag, Zamboanga del Sur.

Section 2. DECLARATION POLICY.

Pursuant to Section 13 of the Philippines Constitution, the state recognizes the vital role of the youth in nation building. It shall promote and protect their physical, moral, spiritual, intellectual and social being, inculcate in their patriotism and nationalism and encourage their involvement in public and civic affairs, thus, Section 30, Chapter VI of RA 10742 otherwise known as the SK Reform Act of 2015 provides that every Local Government Unit shall conduct an annual activity to be known as “*Linggo ng Kabataan*” on the week where the 12th of august falls to coincide with the International Youth day. Through this *Linggo ng Kabataan*, the youth is given a venue that gives due importance to the development of an active and empowerment youth sector.

Section 3. DEFINITION OF TERMS.

- **Youth or Kabataan** – shall refer for those persons whose ages fifteen (15) to thirty (30) years old as defined Republic Act No. 10742.
- **Barangay Youth Organization** – shall refer for those barangay organization whose membership or composition are youth.

Section 4. OBJECTIVES.

The Sangguniang Kabataan (SK) aims to achieve the following purposes:

- To inculcate among youth the love of country, discipline, civic mindedness, unity, courage, respect for the rights of others and sportsmanship.
- To encourage active participation of children and youth in all programs, projects and activities.
- To promote the Sangguniang Kabataan (SK) as an organization and initiator of programs vital for the enhancement of the social, cultural, intellectual, moral, spiritual and physical development of the youth.

- d) To promote as a vehicle for brotherhood and cooperation among youth
- e) To serve as a training ground for the management and implementation of government programs.

Section 5. PROGRAMS AND ACTIVITIES.

During the Celebration of Linggo ng Kabataan the activities shall include but not limited to the following:

Section 6. IMPLEMENTING AGENCY.

The Office of the Municipal Mayor shall be responsible for the implementation of this ordinance thru the Municipal Youth Development Office (MYDO) to lead and oversee to conduct of all programs and activities of Linggo ng Kabataan in coordination with the Municipal Social Welfare and Development Office, Dumingag Organic Culture Office, Liga ng mga Barangay, and Barangay Youth Organizations.

Section 7. BUDGETARY REQUIREMENTS.

All operation cost required for this activity shall be covered with an appropriation to be included in Annual Regular Budget in the amount to be determined by the concern personnel designated by the LCE for the purpose .

Section 8. APPLICABILITY CLAUSE.

The provisions of existing ordinances dealing on the same subject matter which are not in conflict with, or contrary to the provisions of this ordinance are hereby adopted and made an integral part of this ordinance.

Section 9. REPEALING CLAUSE.

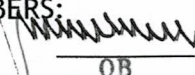
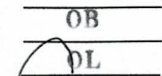
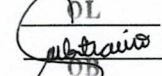
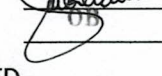
