Municipal Ordinance No. 4, s. 2015

AN ORDINANCE CREATING OF POSITION RENUMERATING OF TWO (2) ITEMS FOR ADMINISTRATIVE AIDE I (SG I) IN THE OFFICE OF THE DUMINGAG TECHNOLOGICAL TRAINING SCHOOL (DTTS) AND LICENSING OFFICER II (SG 15) IN THE OFFICE OF THE MUNICIPAL MAYOR AND PROVIDING FUNDS THEREFOR.

Section 1. TITLE.

This ordinance shall be called, "An ordinance creating the positions of two (2) items for Administrative Aide I (SG I) in the Office of the Dumingag Technological Training School (DTTS) and Licensing Officer II (SG 15) in the Office of the Municipal Mayor respectively and providing funds therefor."

Section 2. CREATION.

This hereby created position shall be included in the Plantilla of personnel of the Local Government Unit of Dumingag, Zamboanga del Sur.

Section 3. APPROPRIATION.

The Municipal Budget Officer shall prepare corresponding budget to cover outlay for the salaries and other emulations due to for the creation of positions as provided for in Section 2 therefore as well as mandatory and statutory obligation to be shouldered by the Municipal Government which shall be reflected every year in the executive annual budget.

Section 4. SEPARABILITY CLAUSE.

Any section or provision of this ordinance maybe declared unlawful or invalid the remainder of such declarations, shall remain to be in full force and effect.

Section 5. EFFECTIVITY.

This ordinance shall take effect upon the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Poblacion.

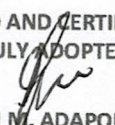

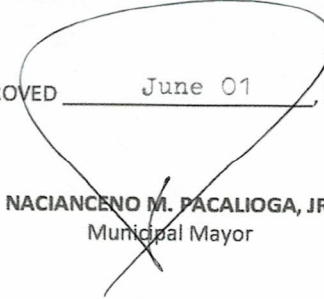
