Municipal Ordinance No. 5, s. 2016

AN ORDINANCE CREATING ADDITIONAL ITEMS IN THE OFFICE OF THE MUNICIPAL ENGINEER OF THE LOCAL GOVERNMENT UNIT OF DUMINGAG, ZAMBOANGA DEL SUR.

Be it enacted by the Sangguniang Bayan Members of Dumingag, Zamboanga del Sur in session assembled:

SECTION 1. TITLE.

This Ordinance shall be called "An ordinance creating items in the Office of the Municipal Engineer of the Local Government Unit of Dumingag, Zamboanga del Sur."

SECTION 2. PURPOSE.

The creation of additional items in the Office of the Municipal Engineer is primarily needed to augment the existing workforce for effective and efficient delivery of services especially in the administration and implementation of infrastructure development and public works projects of the Local Government Unit.

SECTION 3. CREATION. There is hereby created the following items:

POSITION/ITEMS	SALARY GRADE
Driver I	3
Engineer I	12
Engineer I	12
Engineer II	16
Engineer III	19

SECTION 4. SEPARABILITY CLAUSE.

Any section or provision in this ordinance may be declared unlawful or invalid in remainder of such declaration shall remain to be in full force and effect.

SECTION 5. EFFECTIVITY CLAUSE.

This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after 15 days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and 2 other conspicuous places in the Poblacion.
