Municipal Ordinance No. 7, s. 2015

AN AMENDATORY ORDINANCE REQUIRING ALL GEODETIC ENGINEERS CONDUCTING LAND SURVEY WITHIN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR TO COORDINATE WITH THE MUNICIPAL ASSESSOR, SANGGUNIANG BAYAN TO FURNISH COPIES OF THE APPROVED PLANS TO THE OFFICE OF THE MUNICIPAL ASSESSOR IN THIS MUNICIPALITY.

Be it enacted by the Sangguniang Bayan in session assembled that:

Section 1. TITLE.

This ordinance shall be called "AN AMENDATORY ORDINANCE REQUIRING ALL GEODETIC ENGINEERS CONDUCTING LAND SURVEY WITHIN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR TO COORDINATE WITH THE MUNICIPAL ASSESSOR, SANGGUNIANG BAYAN TO FURNISH COPIES OF THE APPROVED PLANS TO THE OFFICE OF THE MUNICIPAL ASSESSOR IN THIS MUNICIPALITY.

Section 2. AUTHORITY.

This measure is in pursuant to Section 211, Chapter 2, Title 2 and Book II of RA No. 7160, otherwise known as the Local Government Code of 1991 states that it shall be the requirement for and the duty of all geodetic engineers, public or private, pursuant to RA 7160, conducting land survey within the municipality, to furnish free of charge to the Municipal Assessor's Office with a white or blue print copy of each approved original or subdivision plans or maps of surveys executed by them within thirty (30) days from receipt of such plans from the Land Management Bureau, the Land Registration Authority or the Housing and Land Use Regulatory Board, as the case may be.

Section 3. OBJECTIVE.

This is to update the records of the Municipal Assessor's Office regarding the status of the lands within the municipality as basis for in taking charge of its duties as provided for in par. (b), Section 472 of RA No. 7160.

Section 4. REQUIREMENT AND COVERAGE.

- Geodetic engineers, private or public conducting survey within this municipality are required to coordinate with the personnel of the Office of the Municipal Assessor and the Office of the Sangguniang Bayan at least one (1) week prior to the conduct of the survey.
- Geodetic engineers, public or private, conducting survey within the municipality, are required to furnish free of charge to the Municipal Assessor's Office with a white or blue print copy of each approved original or subdivision plans or maps of surveys executed by them within thirty (30) days from receipt of such plans from the Land Management Bureau, the Land Registration Authority or the Housing and Land Use Regulatory Board.

Section 5. ENFORCEMENT OFFICE.

The Office of the Municipal Assessor is hereby mandated to enforce this ordinance.

Section 6. PENAL PROVISION.

Any Geodetic Engineer, public or private whether partnership or corporation, found violating this Ordinance shall, upon conviction, be penalized:

1 st offense	P 1,500.00
2 nd offense	P 2,000.00
3 rd & subsequent offenses	P 2,500.00

Section 7. SEPARABILITY CLAUSE.

If any part or provision of this Ordinance shall be held to be invalid, the other parts or provisions hereof not affected thereby, shall continue to be valid and enforceable.

Section 8. EFFECTIVITY.

This ordinance shall take effect upon review of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board at the entrance of the Municipal Hall and at least two (2) other conspicuous places in the Poblacion.

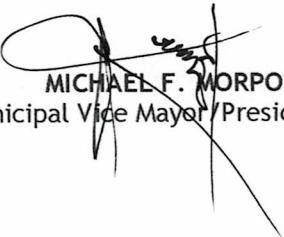

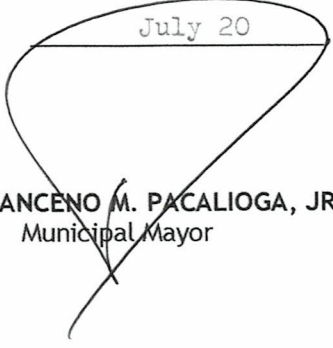
