Ordinance No. 12, s. 2001

AN ORDINANCE PROVIDING A NEW RATE FOR EVERY UNIT OF VINTAGE JUKEBOX
AND VIDEOKE SING-A-LONG.

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled that:

Section 1. TITLE - This ordinance shall be called "AN ORDINANCE PROVIDING A NEW RATE FOR EVERY UNIT OF VINTAGE JUKEBOX AND VIDEOKE SING-A-LONG."

Section 2. MAYOR'S PERMIT - There shall be imposed per unit a Mayor's Permit fee of ONE HUNDRED PESOS (P100.00) for vintage jukebox and TWO HUNDRED PESOS (P200.00) for videoke sing-a-long.

Section 3. TAX ON BUSINESS - There shall be imposed per unit a tax on business to operators or owners of vintage jukebox of THREE HUNDRED PESOS (P300.00) and FIVE HUNDRED PESOS (P500.00) for videoke sing-a-long.

Section 4. IMPLEMENTING RULES AND REGULATIONS - The Municipal Mayor through the recommendation of the Municipal Treasurer shall formulate implementing guidelines for proper implementation of this ordinance..

Section 5. SEPARABILITY CLAUSE - Any section or provisions of this ordinance which may be declared unlawful or invalid, the remainder of such declarations shall remain to be in full force and effect.

Section 6. EFFECTIVITY CLAUSE - This ordinance shall take effect after the review by the Sangguniang Panlalawigan.
