**AN ORDINANCE PRESCRIBING AN ANNUAL PERMIT FEE FOR RUBBER TREE TAPPER (MANANGITE) OF DUMINGAG, ZAMBOANGA DEL SUR**

WHEREAS, the municipality of Dumingag through the Sangguniang Bayan in its endeavour to sustain the economic needs of our people and to develop suited area for rubber plantation, realization shall be made possible through program implementation;

WHEREAS, the Municipal Planning and Development Office in coordination with the Department of Agriculture through its Municipal Office had shown the positive effect in favor of our farmers and Dumingagnons per study in rubber plantation and its production and as other venue for income generation;

WHEREAS, to professionalize rubber tree tapping,

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur

**SECTION 1. TITLE.** This ordinance shall be known as "AN ORDINANCE PRESCRIBING ANNUAL PERMIT FEE FOR RUBBER TREE TAPPER (MANANGITE) OF DUMINGAG, ZAMBOANGA DEL SUR".

**SECTION 2. REGULATORY PROVISION.**

- Only licensed rubber tree tapper can operate anywhere within the municipality. No one can engage in rubber tapping unless he/she can secure permit from the municipal government.
- A certification is to be secured first from the Office of the Municipal Agriculture signed by the Municipal Agriculturist himself before a permit to operate will be issued.
- Prior to the issuance of certification, the Municipal Agriculture must see to it that the person has the ability to tap and the quality in performing the said task is tested and proven. Issuing Officer shall ensure that the said person is qualified to become rubber tapper.

**SECTION 3. IMPOSITION FEE.** There shall be imposed an annual fee of Three Hundred Pesos (P300.00) and permit fee of Forty Pesos (P40.00) to be paid to the Municipal Treasurer.

**SECTION 4. DEFINITION OF TERMS.**

- a. Licensed Rubber Tree Tapper - one that has secured permit to tap from the Municipal Government.
- b. Tap - to pierce in order to draw off liquid
- c. Rubber Tree - (*Havea brasiliensis*), widely cultivated throughout the tropics yielding a milky juice or latex that is a source of commercial rubber
- d. Payment Annually - Manner of payment prescribed in this ordinances

**SECTION 5. PENAL PROVISION.** Any person found guilty of violating any provision of this ordinance shall be penalized with an imprisonment of at least 30 days but not exceeding 60 days and a fine of P2,000.00 or both at the discretion of the court.

**SECTION 6. EFFECTIVITY CLAUSE.** This Ordinance shall take effect after the approval of the Sangguniang Panlalawigan and fifteen (15) days from the date copy of the ordinance is posted in the Bulletin Board at the entrance of the Municipal Hall and at least two (2) conspicuous places in the Poblacion and its publication of newspaper of general circulation in the province.
