Ordinance No. 10, s. 2002

AN ORDINANCE IMPOSING A RATE ON BUSINESS TAX AND MAYOR'S PERMIT FOR FM RADIO STATION OPERATING IN DUMINGAG, ZAMBOANGA DEL SUR.

Be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled that:

Section 1. **TITLE.** This ordinance shall be known as "An Ordinance imposing a rate on Business Tax and Mayor's permit for FM radio Station in Dumingag, Zamboanga del Sur.

Section 2. **TAX ON BUSINESS.** There shall be imposed a Business Tax to Operators of FM radio Station in the amount of P1,500.00 per annum.

Section 3. **MAYOR'S PERMIT.** Any Radio operator applicants for renewal shall be charged the amount of P1000.00 for Mayor's permit.

Section 4. **IMPLEMENTING RULES AND REGULATIONS.** The Municipal Mayor through the recommendation of the MTO shall formulate implementing guidelines for proper implementation of this ordinance.

Section 5. **SEPARABILITY CLAUSE.** Any section or provision of this ordinance which may/be declared unlawful or invalid, the remainder of such declaration shall remain to be in full force and effect.

Section 8. **EFFECTIVITY AND PUBLICATION CLAUSE.** This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Poblacion, announcement in the local cable TV and FM station and further, published in a local newspaper of general circulation once a week for three consecutive weeks, informing the constituents of the provisions and date of effectivity thereof.
