ORDINANCE NO. 2, s. 2011

AN ORDINANCE REQUIRING ALL PUBLIC MOTOR VEHICLE OPERATORS TO COMPLY WITH THE REQUIREMENTS IN THE ISSUANCE OF BUSINESS PERMIT FOR ITS OPERATION WITHIN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.

Be it enacted by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled that:

Section 1. TITLE.

This ordinance shall be called, "An Ordinance requiring all Public Motor Vehicle operators to comply with the requirements in the issuance of Business Permit for its operation within the Municipality Of Dumingag, Zamboanga Del Sur."

Section 2. PURPOSE.

This ordinance aims to ensure compliance and adherence to proper and standard requirements in the operation of public motor vehicles that will redound to the safety and welfare of the riding public.

Section 3. REQUIREMENTS/MANDATORY PROVISION.

a. No business permit shall be issued by the LGU to all operators of public motor vehicles without complying the following requirements.

• **Van, bus and jeepney**

1. Franchise from the Land Transportation Franchising Regulatory Board (LTFRB)
2. Barangay Clearance
3. Residence Certificate
4. Certificate of Registration (CR) and Official Receipt (OR) of the unit
5. Driver's License (for the driver)
6. Mayor's permit

• **Motor and motorized tricycle**

1. Barangay Clearance
2. Police Clearance
3. Residence Certificate
4. Certificate of Registration (CR) and Official Receipt (OR) of the unit
5. Driver's License (for the driver)
6. Mayor's permit

b. Operators shall not allow any person to drive his/her motor vehicle without driver's license. The operator shall be held responsible for damages/charges resulting from non-compliance or violation thereof.

Section 4. ENFORCEMENT OFFICE.

The Office of the Municipal Treasurer and the Philippine National Police are directed to strictly enforce this ordinance.

Section 5. PENAL PROVISION.

Any person/persons found violating the provisions of this ordinance shall be fined in the amount of Five Hundred Pesos (P 500.00) for 1st offense, One Thousand Pesos (P 1,000.00) for 2nd offense, and One Thousand Five Hundred Pesos (P 1,500.00) for 3rd and subsequent offenses or by imprisonment of not less than 3 months or both at the discretion of the court.

Section 6. REPEALING CLAUSE.

Any provision of this ordinance found in conflict or inconsistent shall be repealed or modified accordingly.

Section 7. EFFECTIVITY CLAUSE.

This ordinance shall take effect upon the review and approval of the Sangguniang Panlalawigan and 15 days after a copy hereof is posted in the bulletin board in the Municipal Hall, and two other conspicuous places and published in a newspaper for general information.

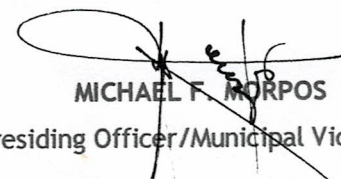
