ORDINANCE No. 3, 1997

AN ORDINANCE GRANTING TAX INCENTIVE TO THE MOTOR-CAB AND SINGLE MOTOR OPERATOR/OWNER AND PENALTIES FOR ANY VIOLATIONS THEREOF. (JUN PACALIOGA)

Be it ordained by the SB of Dumingag, Zamboanga del Sur in session assembled that :

SECTION 1 - Title - This ordinance shall be called "AN ORDINANCE GRANTING TAX INCENTIVE TO THE MOTOR-CAB AND SINGLE MOTOR OPERATOR/ OWNER AN IMPOSING PENALTIES FOR ANY VIOLATIONS THEREOF"

SECTION 2 - Purpose - As part of the fundamental principle governing the the taxing and other revenue generated powers of the LGU, that taxes shall be equitable and based, as far as practicable, on the taxpayer's ability to pay, this ordinance aims to provide a new schedule of fair imposition of taxes and fees to the said Sector in their operation

SECTION 3 - NEW ADJUSTMENT SCHEDULE - Taxes and Regulatory fees are as follows:

1. MOTOR CAB (including motorilla)
 - A. Regulatory Fees P100.00
 1. Mayor's Permit P40.00
 2. Tax Clearance 20.00
 3. Police Clearance 10.00
 4. Mayor's Clearance 10.00
 5. Registration Fee 20.00
 - B. Supervising Fee P 50.00
 - C.. Tax on Business 200.00
 - D. TOTAL P350.00

2. SINGLE MOTOR

Taxes and fees of the motor Single engaged in public utility business are equal to those Motor Cab as stated above.

SECTION 4 - PENAL PROVISIONS - Any person/operator/owner found guilty of violating these ordinance shall be penalized by a fine of not less than P500.00 but not more than P800.00 or an imprisonment of not less than two days, but not more than one week, or both at the discretion of the court.

SECTION-5 - ADMINISTRATIVE PROVISION - The Municipal Treasurer shall be implementor of this ordinance.

SECTION-6 - SEPARABILITY CLAUSE - Any part or provision of this ordinance which shall be held unconstitutional or invalid, other parts of this not affected thereby shall continue in full force and effect.

SECTION-7 - REPEALING CLAUSE - Any resolution or ordinance inconsistent hereof is hereby modified, repealed or superseded accordingly.

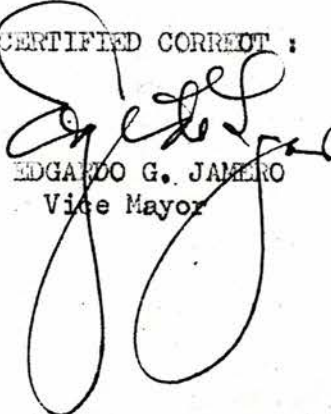
SECTION-8 - EFFECTIVITY - This ordinance shall take effect immediately upon approval.

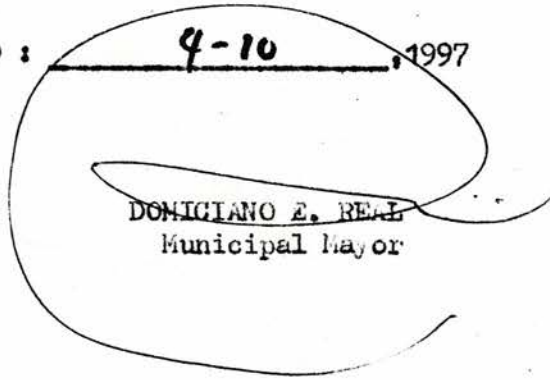
