Ordinance No. 3, s. 2008

AN ORDINANCE CREATING THE MUNICIPAL ECONOMIC DEVELOPMENT OFFICE (MEDO) AND PROVIDING FUNDS THEREOF.

Be it ordained by the Sangguniang Bayan in session assembled that:

Section 1. TITLE. This Ordinance shall be called "An Ordinance Creating the Municipal Economic Development Office (MEDO) and Providing Funds Thereof.

Section 2. DECLARATION OF POLICIES AND PURPOSE. Pursuant to the present administration's direction, it is the policy of the municipality to enjoin all sectors of society to pursue thrust programs and projects aimed at accelerating economic growth, developing potential economic resources, promoting favorable economic climate for business potential and enhancing potential income-generating projects all pointing towards economic growth and development that would benefit people from all walks of life.

Section 3. CREATION OF THE MUNICIPAL ECONOMIC DEVELOPMENT OFFICE. There is hereby created, the Municipal Economic Development Office herein after referred to as MEDO which shall be directly under the Municipal Mayor's Office.

Section 4. FUNCTIONS OF MEDO

- 4.1 To act as an extension arm of the Chief Executive in implementing policies, directions, plans and programs for economic development of the municipality;
- 4.2 To lead the promotion of business and provide favorable atmosphere as an avenue for attracting more business and tourism ventures toward the municipality;
- 4.3 To initiate and sustain data bank and information exchange and dissemination system to promote and advertise the municipality and its potentials;
- 4.4 Initiate income-generating project (IGP) adding up to the local business activity thereby augmenting the income of the municipality and its constituents;
- 4.5 To do other task as may be assigned by the Local Chief Executive.

Section 5. COMPOSITION OF MEDO. The Municipal Economic Development Office shall be composed of the following:

- 5.1 One (1) Municipal Development Officer V with the salary grade Twenty Four (24) Level I

5.2 One (1) Municipal Economic Researcher with salary grade IX, Level I

5.3 Two (2) Municipal Clerk I with salary grade III, level I

Section 6. BUDGETARY AND FINANCE REQUIREMENT. All salaries and wages of the items created under this ordinance as well as its maintenance and operation cost for the Fiscal Year beginning January 2008 shall be covered with an appropriation to be included in the Annual Regular Budget in the amount to be determined by the concerned personnel designated by the Local Chief Executive for the purpose.

Section 7. SEPARABILITY CLAUSE. Any provision of this Ordinance or part thereof declared unconstitutional or unlawful, the other parts not affected shall remain in full force and effect.

Section 8. REPEALING CLAUSE. Any part of provisions of this Ordinance in conflict with or contrary to the existing ordinances are hereby repealed, amended or modified accordingly.

Section 9. EFFECTIVITY CLAUSE. This ordinance shall take effect immediately upon its approval.
