Ordinance No. 3, s. 2010

AN ORDINANCE ORDAINING A "POST - A - NO SMOKING SIGN" RULE IN ALL PUBLIC CONVEYANCES, SCHOOLS, BUSINESS ESTABLISHMENTS AND OTHER PLACES FREQUENTED BY CROWDS AND IMPOSING PENALTIES AND SANCTIONS FOR VIOLATION THEREOF.

Be it enacted by the Sangguniang Bayan of Dumingag, Zamboanga del Sur, in session assembled that:

Section 1. PURPOSE. In order to further strengthen and solidify the ANTI-SMOKING policy and program of the municipality, it is necessary that there shall be a thorough implementation of the Anti-Smoking Ordinance.

Section 2. BASIS. This Ordinance is based on the following provisions of Municipal ordinance no. 4, s. 1997, as amended:

Section 3.1 of the Municipal is Ordinance No. 4, s. 1997 as amended, read as follows:

3.1 No person shall smoke in a closed, walled or air-conditioned building or room/s, viz., inside government offices, schools, hospitals/clinics, barangay or municipal halls; session halls; convention/training/seminar centers; cinema houses; video centers; all public conveyances; all eateries such as but not limited to restaurants, cafeterias, carenderias, bakeshops, cafés; all types of stores/shopping centers; and, other places frequented by crowds such as kiosks and waiting sheds except in designated smoking areas.

Section 3.3 of the Municipal is Ordinance No. 4, s. 1997 as amended read as follows:

3.3 All public conveyances and other establishments mentioned in section 3.1 must display "NO SMOKING" OR "GIDILI ANG PAGTABAKO" and "THANK YOU FOR NOT SMOKING" posters/stickers in conspicuous areas/places to warn people of the existing no smoking ordinance of the municipality.

Section 3. REGULATORY PROVISION. All owners/operators of public conveyances, schools and business establishments in the municipality are hereby mandated and required to display and or post a POSTER/STICKER/BILLBOARD in a conspicuous area where the business is conducted containing the words of warning mentioned in sec. 3.3 of Municipal Ordinance No. 4 as amended.

Section 4. PENAL PROVISIONS. Any person, operator, owner and/or officials in case of juridical persons who failed to comply with the provisions of this ordinance upon conviction, shall be

fined of Five Hundred (P500.00) Pesos and further that non-compliance shall be a ground for suspension and/or revocation of the business permit of the entity involved.

Section 5. REPEALING CLAUSE. Any existing resolutions, ordinances or parts thereof which are inconsistent with this ordinance are hereby modified, repealed or superseded accordingly.

Section 6. SEPARABILITY CLAUSE. Any provision or part of this ordinance may be declared invalid or unconstitutional, other parts or provisions not affected thereby shall continue in full force and effect.

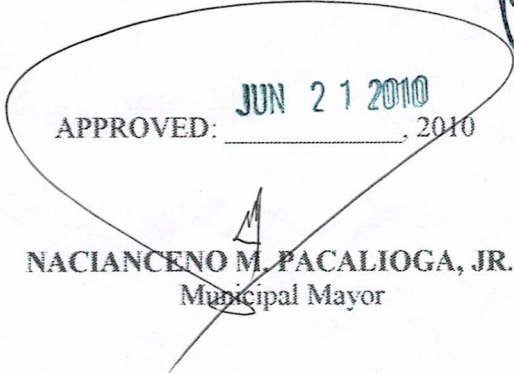
Section 7. EFFECTIVITY AND PUBLICATION CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy thereof is posted in the bulletin board at the entrance of the Municipal Hall and at least two (2) conspicuous places in the Poblacion and its publication in a newspaper of general circulation in the province.

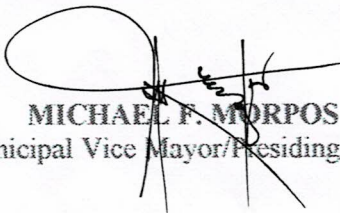
