Ordinance No. 4, s. 2003

AN ORDINANCE CREATING THE ITEM OF NUTRITION OFFICER I AT THE OFFICE OF THE
MUNICIPAL MAYOR, DUMINGAG, ZAMBOANGA DEL SUR.

Be it enacted by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in
session assembled that:

Section 1. TITLE - This ordinance shall be called "AN ORDINANCE CREATING
THE ITEM OF NUTRITION OFFICER 1 AT THE OFFICE OF THE MUNICIPAL MAYOR."

Section 2. CREATION - There is hereby created position of one (1)
Nutrition Officer 1 to be included in the plantilla of personnel of the Local
Government Unit (LGU) of Dumingag, Zamboanga del Sur under the Municipal
Mayor's Office.

Section 3. SALARY GRADE - The salary grade of Nutrition Officer 1 shall be
Salary Grade 10.

Section 4. COMPENSATION - The annual salary and other emoluments due for
the created position shall be ONE HUNDRED SEVENTY ONE THOUSAND SIX HUNDRED FOUR
PESOS AND FIFTY TWO CENTAVOS (P171,604.52) less 2% which shall be a
mandatory and statutory obligations to be shouldered by the municipal
government

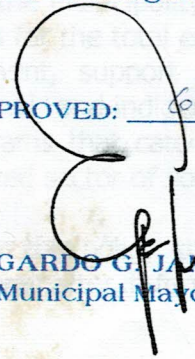
Section 5. SEPARABILITY CLAUSE - Any section or provisions of this
ordinance which may be declared unlawful or invalid, the remainder of such
declarations shall remain to be in full force and effect.

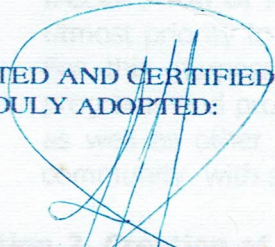
Section 6. EFFECTIVITY - This ordinance shall take effect upon its
approval.

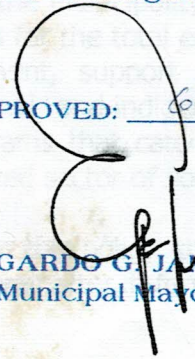
