Ordinance No. 4, s. 2005

AN ORDINANCE GRANTING THE MUNICIPAL ACCOUNTANT THE AUTHORITY TO SUPPLY THE FORTY-FOUR (44) BARANGAYS OF DUMINGAG, ZAMBOANGADEL SUR, WITH DIFFERENT ACCOUNTING FORMS AND REPORTS FOR A FEE.

Be it enacted by the Sangguniang Bayan in session assembled that:

Section 1. TITLE. This ordinance is entitled, "An Ordinance Granting The Municipal Accountant The Authority To Supply The Forty-Four (44) Barangays of Dumingag, Zamboanga del Sur With Different Accounting Forms And Reports For a Fee."

Section 2. PRELIMINARY STATEMENT. Article 218 of the RA 7160 otherwise known as the Local Government Code of 1991 provides the power of the LGU to create its own sources of revenue and to levy taxes, fees or charges.

Section 3. PURPOSE. This ordinance aims to raise revenue to finance or support government expenditures in the interest of public service.

Section 4. DEFINITION OF TERMS. For the purpose of this ordinance, the term shall mean:

RIV - Requisition And Issue Voucher

Section 5. FEES. The following fees shall be collected on forms and reports issued:

- a. Accounting forms (100 sheets per pad) - P50/pad + 10% surcharge
- b. New barangay cashbook (300 pages) - P400 +10% surcharge

Section 6. POLICIES AND GUIDELINES. The following are the Policies and Guidelines in the implementation of this ordinance.

- a. The respective barangays shall procure said forms pursuant to the implementation of New Government Accounting System with the use of RIV duly signed by the Barangay Captain concerned. The corresponding amount shall be paid to the Municipal Treasurer.
- b. All collections shall accrue to the Trust Fund of the Local Government Unit of Dumingag.
- c. The income earned shall be used to defray the Maintenance and Other Operating Expenses (MOOE) of the Office of the Municipal Accountant. All disbursements from this fund shall be in accordance with the existing accounting and auditing regulations.

Section 7. AUTHORITY. The Municipal Accountant is hereby authorized to supply and provide the forty-four (44) barangays within the territorial jurisdiction of Dumingag with accounting forms and reports based on the fees provided in Section 5 of this ordinance.

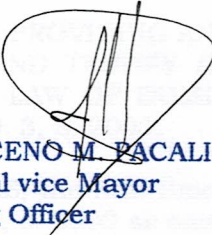
Section 8. SEPARABILITY CLAUSE. If any portion or section of this ordinance is declared void or unconstitutional, the remaining portions thereof shall not be affected by such declaration.

Section 9. REPEALING CLAUSE. Any ordinance, order, memoranda, rules and regulations or parts thereof inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 10. EFFECTIVITY CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Poblacion, published in a local newspaper of general circulation once a week for three consecutive weeks or posted in the municipal hall of all municipalities within the province of Zamboanga del Sur.

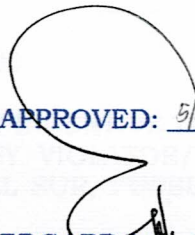
