Ordinance No. 5, s. 2006

AN ORDINANCE AMENDING SECTION 5 - PARAGRAPH A. RULES AND MECHANICS FOR ACCREDITATION UNDER MUNICIPAL ORDINANCE NO. 1, S. 2005 BY PROVIDING ADDITIONAL REQUIREMENT TO SUPPORT THE REGISTRATION OF NGOS FOR ACCREDITATION BY THE SANGGUNIANG BAYAN

WHEREAS, Section 5 - paragraph a of Municipal Ordinance No. 1, s. 2005 provides the Rules and Mechanics for Accreditation as follows:

Section 5. RULES AND MECHANICS FOR ACCREDITATION. There is hereby established rules and mechanics for accreditation of NGOs, to wit:

a. Applicant-organization shall file and submit the required papers/documents to the Sangguniang Bayan through the SB Secretary:

1. Application letter duly signed by the head of the organization;
2. Board Resolution requesting the Sangguniang Bayan for accreditation;
3. List of officers and members of the organization duly certified by the Secretary;
4. Xerox copy of SEC/CDA registration and other documents necessary for the legal operation of the organization;

WHEREAS, one of the important documents to be submitted necessary and indispensable for its accreditation is the NGO's Constitution and By-Laws which is not specifically required under Section 5 - paragraph a of Municipal Ordinance No. 1, s. 2005;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled that:

Section 1. TITLE. This Ordinance shall be called, "An Ordinance Amending Section 5 - paragraph a. Rules and Mechanics for Accreditation under Municipal Ordinance No. 1, s. 2005 by Providing Additional Requirement to Support the Registration of NGOs for Accreditation by the Sangguniang Bayan".

Section 2. PURPOSE. The purpose of said ordinance is to require all NGOs to submit copies of their approved Constitution and By-laws which mandates their existence as constituted for their legal operation under the law.

Section 3. SCOPE OF APPLICATION. This Ordinance shall apply to all NGOs within the municipality of Dumingag, Zamboanga del Sur.

Section 4. REGULATORY PROVISIONS. No NGO shall be recognized by the LGU for representation or membership to any committee council or any special body created by law or initiated by the government unless accredited by the Municipal Government through the

Section 5. AMENDED RULES AND MECHANICS FOR ACCREDITATION. There is hereby established rules and mechanics for accreditation of NGOs, to wit:

a. Applicant-Organization shall file and submit the required papers/documents to the Sangguniang Bayan through the SB Secretary pursuant to Section 5 - paragraph a of Municipal Ordinance No. 1, s. 2005 with additional supporting papers/documents for submission, to wit:

No. 5. Copies of NGO's Constitution and By-Laws

Section 6. SEPARABILITY CLAUSE. Any part or provision of this ordinance which maybe held invalid, the other parts or provisions herein not affected thereby shall remain to be in full force and effect.

Section 7. EFFECTIVITY AND PUBLICATION CLAUSE. This Ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after 15 days from the date copy hereof is posted in the Bulletin Board at the entrance of the Municipal Hall and at least two (2) conspicuous places in the Poblacion.
