Ordinance No. 5, s. 2012

AN ORDINANCE CREATING THE ITEMS OF HUMAN RESOURCE MANAGEMENT ASSISTANT 2 AND ADMINISTRATIVE AIDE 1 AT THE OFFICE OF THE MUNICIPAL MAYOR, DUMINGAG, ZAMBOANGA DEL SUR.

Be it enacted by the Sangguniang Bayan of Dumingag, Zamboanga del Sur in session assembled:

Section I. TITLE.

This ordinance shall be called "An ordinance creating Human Resource Management Assistant 2 (HRMA 2) and Administrative Aide 1 at the Office of the Municipal Mayor."

Section II. CREATION.

There is hereby created a position of one Human Resource Management Assistant 2 and Administrative Aide 1.

Section III. SALARY GRADE.

The salary grade of HRMA 2 shall be SG 10 and Administrative Aide shall be SG 4.

Section V. SEPARABILITY CLAUSE.

Any section or provision of this ordinance which may be declared unlawful or invalid, the remainder of such declarations shall remain to be in full force and effect.

Section VI. EFFECTIVITY.

This ordinance shall take effect upon its approval.
