Ordinance No. 6, s. 2005

AN ORDINANCE MANDATING THE MUNICIPAL LOCAL CIVIL REGISTRAR'S OFFICE TO REQUIRE A BARANGAY CERTIFICATION PRIOR TO THE REGISTRATION OF BIRTHS, MARRIAGES AND DEATHS IN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.

WHEREAS, the registration of births, marriages and deaths is required by law and pursuant to the Local Government Code, barangay secretaries are required to assist the municipal civil registrar in the registration of births, marriages and deaths and to keep and updated record of all inhabitants of the barangay;

WHEREAS, the registration of the births, marriages and deaths can be safeguarded, effectively implemented and the occurrence of erroneous or fraudulent registration can be minimized and/or avoided if there is a cooperation and participation of the barangay;

NOW, THEREFORE, be it ordained by the Sangguniang Bayan in session assembled:

SECTION 1. TITLE. This ordinance shall be called as "An Ordinance Mandating the Municipal Local Civil Registrar's Office to Require a Barangay Certification Prior to the Registration of Births, Marriages and Deaths in the Municipality of Dumingag, Zamboanga del Sur."

SECTION 2. PURPOSE. This ordinance is enacted in order to empower the barangay in the registration of births, marriages and deaths and to minimize the erroneous and/or fraudulent registration of births, marriages and deaths;

SECTION 3. DEFINITION OF TERMS:

1. Barangay Certification. A written certification prepared by the barangay secretary and duly signed by the Barangay Captain indicating the facts required in the registration in the civil registry.
2. Local Civil Registrar's Office. Refers to the Office of the Municipal Civil Registrar tasked to record and register the births, marriages and deaths, and the like in the Municipality of Dumingag, Zamboanga del Sur.

SECTION 4. REGULATORY PROVISIONS. The Local Civil Registry Office is hereby mandated to perform the following:

- a. That prior to getting birth, marriage and death certificates, a Barangay Certification must be secured/required first in order to avoid and minimized the erroneous and fraudulent registration of birth, marriage or death
- b. That in case of registration of marriage, a Barangay Certification must be sought first. The certification must state the fact that the marriage has taken place
- c. That the Municipal Local Civil Registrar's Office shall exempt cultural minorities from payment of registration fees
- d. That the barangay must make an ordinance fixing fees on barangay certification

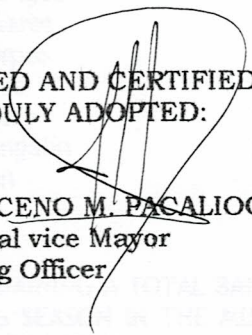
SECTION 5. REPEALING CLAUSE. Any provisions of a resolution or an ordinance found inconsistent with the provisions of this ordinance are hereby modified and/or repealed accordingly.

SECTION 6. EFFECTIVITY CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and fifteen (15) days from the date copy hereof is posted in the Bulletin Board at the entrance of the Municipal Hall and at least two (2) other conspicuous places in the Poblacion.

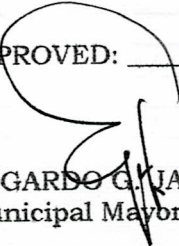
