Ordinance No. 7, 2003

AN ORDINANCE AMENDING SECTIONS 2.3 AND 5 OF ORDINANCE NO. 40, S. 2002 ENTITLED, 'AN ORDINANCE FIXING RATES FOR THE RENTAL OF THE LGU HEAVY EQUIPMENT OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.'

Be it ordained by the Sangguniang Bayan in session assembled that :

Section 1. TITLE. This ordinance shall be called, "An Ordinance Amending Sections 2.3 and 5 of Ordinance No. 40, s. 2002 Entitled, 'An Ordinance Fixing Rates For The Rental of the LGU Heavy Equipment of the Municipality of Dumingag, Zamboanga del Sur.' "

Section 2. RENTAL, FEES AND CHARGES. There shall be imposed rental for the use of heavy equipment in the following breakdown:

2.1. Rental Rate Per Day

2.2. For Ten (10) Wheeler Dumptruck-Loaded with Sand and Gravel. An amount of Five Hundred Pesos (P500.00) per load shall be charged for the first 5 kilometres plus Fifty Pesos (P50.00) for every succeeding kilometre.

2.3. For Ten (10) Wheeler Dumptruck-Loaded with Timber. An amount of Eight Hundred Pesos (P800.00) per load shall be charged for the first 5 kilometres plus Fifty Pesos (P50.00) for every succeeding kilometre.

2.4. For Six (6) Wheeler Dumptruck-Loaded with Sand and Gravel. An amount of Three Hundred Pesos (P300.00) per load shall be charged for the first 5 kilometres plus Fifty Pesos (P50.00) for every succeeding kilometre.

2.5. For Six (6) Wheeler Dumptruck-Loaded with Timber. An amount of Five Hundred Pesos (P500.00) per load shall be charged for the first 5 kilometres plus Fifty Pesos (P50.00) for every succeeding kilometre.

Section 3. IMPLEMENTING RULES AND REGULATIONS. The Municipal Mayor through the recommendation of the Municipal Treasurer shall formulate implementing guidelines for the proper implementation of this ordinance.

Section 4. SEPARABILITY CLAUSE. If any portion of this ordinance is held unconstitutional or invalid other parts not affected thereby shall remain to be in full force and effect.

Section 5. REPEALING CLAUSE. Any law of local application found to be inconsistent with this ordinance is hereby repealed or modified accordingly.

Section 6. EFFECTIVITY AND PUBLICATION CLAUSE. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Poblacion, announcement in the local cable TV and FM station and further, published in a local newspaper of general circulation once a week for three consecutive weeks, informing the constituents of the provisions and date of effectivity thereof.
