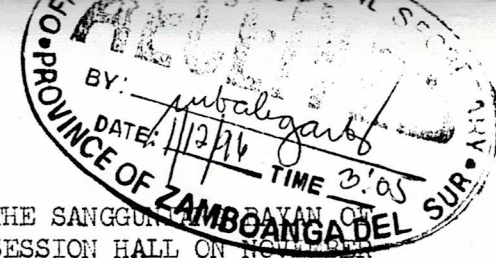

ORDINANCE NO. 7, S. 1995

AN ORDINANCE LIMITING/FIXING THE EMBALMING OF HUMAN MORTAL REMAINS/ CADAVER WITHIN THE FUNERAL PARLOR OR EMBALMING HOUSE ONLY AND IMPOSING FINES/PENALTIES FOR VIOLATION THEREOF. AUTHOR HONORABLE EDMAN AMBIL, CO-AUTHOR HONORABLE JUN PACALIOGA.

WHEREAS, the lifeless human anatomy, created in the image and likeness of the Creator, deserve utmost care, due respect and veneration, preparatory to its final journey to the Great Beyond;

Be it ordained by the Sangguniang Bayan in session assembled:

Section I - This ordinance shall be known as the ordinance fixing the embalming of the mortal remains/cadaver within a licensed funeral shop/parlor only.

Section II - It shall be taboo, unlawful/unsanitary to undertake embalming services at the subject's house, any public place or area, other than at a licensed shop/parlor in the municipality;

Section III - A parlor operator/owner/employee who willfully violate this ordinance shall be fined/penalized, as follows:

First Offense - Fine off P100 to P200, imprisonment of 5 to 10 days

Second Offense - Fine off P200 to P500, imprisonment of 10 to 15 days

Third Offense - Fine of P500 to P1,000, imprisonment of 15 to 30 days

Section IV - Any previous ordinance inconsistent herewith is hereby superceded/repealed accordingly.

Section V - This ordinance shall take effect after its review and approval by the Sangguniang Bayan, compliance with public hearing and posting requirements.
