Ordinance No. 8, s. 2001

AN ORDINANCE CREATING THE POSITION OF ANIMAL KEEPER III IN THE MUNICIPAL AGRICULTURE OFFICE.

Be it enacted by the Sangguniang Bayan of Dumingag, Zambo. Sur in session assembled that:

Section 1. TITLE - This ordinance shall be called "AN ORDINANCE CREATING THE POSITION OF ANIMAL KEEPER III IN THE MUNICIPAL AGRICULTURE OFFICE."

Section 2. CREATION - There is hereby created a position of one (1) Animal Keeper III to be included in the plantilla of personnel of the Local Government Unit (LGU) of Dumingag, Zamboanga del Sur under the Municipal Agriculture Office.

Section 3. SALARY GRADE - The salary grade of Animal Keeper III shall be SG 9.

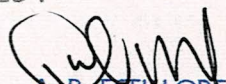
Section 4. APPROPRIATION - The annual salary and other emoluments due for the created positions shall be ONE HUNDRED SIX THOUSAND FOUR HUNDRED EIGHTY EIGHT PESOS (P106,488.00) which shall be reflected every year in the Executive Budget as well as mandatory and statutory obligations to be shouldered by the municipal government.

Section 5. SEPARABILITY CLAUSE - Any section or provisions of this ordinance which may be declared unlawful or invalid, the remainder of such declarations shall remain to be in full force and effect.

Section 6. EFFECTIVITY CLAUSE - This ordinance shall take effect after the review by the Sangguniang Panlalawigan.

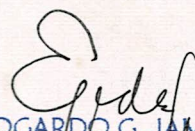
