Ordinance No.2, s. 2008

AN ORDINANCE PRESCRIBING FEES FOR RENTALS OF THE UTILIZED BLOCK OF THE MUNICIPAL GYMNASIUM FOR BUSINESS, COMMERCIAL AND OTHER PROFIT ORIENTED PURPOSES.

Be it ordained by the Sangguniang Bayan in session assembled that,

Section 1. This ordinance shall be called, "An Ordinance Prescribing Fees for Rentals of the Utilized Block of the Municipal Gymnasium for Business, Commercial and Other Profit Oriented Purposes."

Section 2. Rental, Fees and Charges. There shall be imposed rental for the use of block of Municipal Gymnasium at a rate of THREE THOUSAND FIVE HUNDRED PESOS (P3,500.00) per block per month.

Section 3. Implementing Rules and Regulations. The Municipal Mayor through the recommendation of the Municipal Treasurer shall formulate implementing guidelines for the proper implementation of this ordinance.

Section 4. Separability Clause. Any part of the provisions of this ordinance which maybe held invalid, the other parts of the provisions herein not affected thereby shall remain to be in full force and effect.

Section 5. Repealing Clause. All other ordinances and resolutions inconsistent with the provisions of this ordinance are hereby repealed accordingly.

Section 6. Effectivity Clause. This ordinance shall take effect after the approval of the Sangguniang Panlalawigan and after fifteen (15) days from the date copy hereof is posted in the bulletin board at the entrance of the municipal hall and in at least two (2) other conspicuous places in the Poblacion, published in a local newspaper of general circulation once a week for three consecutive weeks and/or posted in the municipal hall of all municipalities within the province.
