Ordinance No.6, s. 2006

AN ORDINANCE DECLARING 3RD WEEK OF JULY OF EVERY YEAR AS THE ORGANIC FRIENDLY WEEK OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR AND PROVIDING GUIDELINES FOR ITS IMPLEMENTATION.

Be it enacted by the Sangguniang Bayan in session assembled that:

Section 1. TITLE. An Ordinance Declaring 3rd week of July of Every Year as the Organic Friendly Week of the Municipality of Dumingag, Zamboanga del Sur and Providing Guidelines for its implementation.

Section 2. LEGAL BASES. This Ordinance is enacted to support the food security program of the municipality and to Supplement Municipal Ordinances No. 13, s. 2002 entitled, "An Ordinance Penalizing the Burning of Agricultural By - Products Within the Municipality of Dumingag, Zamboanga del Sur" and Municipal Ordinance No. 8, s. 2003 entitled, "An Ordinance Adopting Sustainable Agriculture in the Municipality of Dumingag, Zamboanga del Sur, Providing Measures for Its Adoption and Funds for Implementation Thereof." It is also enacted in order to develop awareness in farmers of the importance of organic farming.

Section 3. DEFINITION OF TERMS.

- 3.1. Organic farming. Farming using organic fertilizers
- 3.2. Organic fertilizer. Fertilizer derived from farm residues and animal manure and dung and guano
- 3.3. FA. Farmers Association
- 3.4. RIC. Rural Improvement Club
- 3.5. FAITH. Food Always In The Home

Section 4. DECLARATION OF POLICY. There is hereby declared policy of the municipality of Dumingag to observe Organic Friendly Week to be held on the 3rd week of July every year.

Section 5. GUIDELINES FOR THE IMPLEMENTATION

5.1. The municipality, through the Office of Agriculture, shall spearhead the activities to be undertaken during the organic friendly week.

5.2. There shall also be a week-long activities in the barangays with the members of the FA, RIC, 4H Club in partnership with the Barangay Council spearheading these activities.

5.3 In order to solicit full participation of farmers, POs, NGOs and other centers

5.4. Activities during the week-long celebration shall include but not limited to the following:

1. Demonstration/training on making organic fertilizer and pesticide/fungicide and feeds of hogs and poultry
2. Plant propagation
3. Plant breeding
4. FAITH gardening
5. Agricultural land technology
6. Composting
7. Recognition of farmers adopting organic farming

Section 6. ENFORCEMENT PROVISION. The Municipal Mayor shall implement this program with the Municipal Agriculture Office as the lead agency in translating the provisions therein into action. The FITS Center shall be tasked in the provisions of the necessary literature needed to concretize the program and to document including the pictorials needed for posterity.

SECTION 7. EFFECTIVITY CLAUSE. This Ordinance shall take effect after the approval of the Sangguniang Panlalawigan and fifteen (15) days from the date copy of this ordinance is posted in the Bulletin Board at the entrance of the Municipal Hall and at least two (2) conspicuous places in the Poblacion.
