AN EXECUTIVE ORDER ON THE REORGANIZATION OF THE CORE TEAM FOR THE FORMULATION OF THE MUNICIPAL CLIMATE CHANGE ACTION PLAN (MCCAP) IN THE MUNICIPALITY OF DUMINGAG.

WHEREAS, Republic Act No. 7160, otherwise known as the “Local Government Code of 1991”, mandates the Local Government Units to share with the National Government the responsibility in the management and maintenance of ecological balance in their respective territorial jurisdiction;

WHEREAS, Section 11(2) of RA 10121, otherwise known as the “Disaster Risk Reduction and Management Act 2010”, provides that the LGUs shall ensure the integration or mainstreaming of disaster risk reduction and climate change adaptation into local development plans, program and budgets as a strategy in sustainable development and poverty reduction;

WHEREAS, Section 14 of RA 9729, otherwise known as the “Climate Change Act of 2009”, as amended by RA 10174, or the “People’s Survival Fund Act”, provides that the LGUs shall be the frontline agencies in the formulation, planning and implementation of Climate Change action plans in their respective areas;

WHEREAS, the Department of the Interior and Local Government (DILG) Memorandum Circular No. 2014-135 dated October 21, 2014, entitled “Guidelines on the Formulation of the Local Climate Change Action Plan (LCCAP)”, provides guidance to Local Government Units on the organization of a core team that shall lead, oversee, and ensure the formulation, approval, implementation, monitoring, and updating of the Local Climate Change Action Plan;

WHEREAS, there is a need to create a Core Team who will closely and collaboratively work for the successful formulation of the Municipal Climate Change Action Plan of the Municipality of Dumingag.

NOW THEREFORE, I, GERRY T. PAGLINAWAN, Mayor of the Municipality of Dumingag, by virtue of the powers vested in me by law, do hereby order the adaptation of the reconstitution of the Core Team of the Municipal Climate Change Action Plan of the Municipality of Dumingag.

SECTION 1. COMPOSITION.

The MCCAP Core Team shall be composed of, but not limited to the following:

SECTION 2. DUTIES AND RESPONSIBILITIES.

The Core Team, shall exercise the following functions, to wit:

To engage in the following activities:

- Interfacing with the LCE and other local functionaries concerned
- Issuance of EO creating the MCCAP Core Team
- Climate and Disaster Risk Assessment (CDRA) Finalization
- Greenhouse Inventory

- Formulation of Draft of MCCAP
- Finalization of MCCAP
- Submission of MCCAP to the Sanggunian
- To faithfully observe the timeline for the implementation of Municipal Climate Change Action Plan
- To regularly update the undersigned of the status of progress of the implementation of the Plan of Action
- Upon approval of the MCCAP, the MCCAP Core Team shall regularly monitor and update when necessary the MCCAP.

SECTION 3. MEETING.

The MCCAP Technical Working Group shall meet quarterly or as often as necessary.

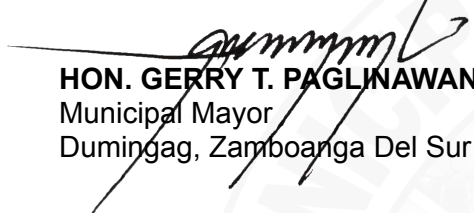
SECTION 4. REPEALING CLAUSE.
