AN EXECUTIVE ORDER THE CREATION OF THE RETOOLED SUPPORT COMMUNITY PROGRAM (RSCP) IN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR

WHEREAS, the Local Government Unit recognizes the need to strengthen community-based support systems to promote social development, inclusive growth, and responsive public service delivery;

WHEREAS, the Retooled Support Community Program (RSCP) aims to enhance collaboration among national government agencies, the local government, civil society organizations, and community stakeholders to address local needs through coordinated planning, implementation, and monitoring of programs and projects;

WHEREAS, the implementation of the Retooled Support Community Program will contribute to improved access to government services, community empowerment, and sustainable development at the grassroots level;

NOW, THEREFORE, I, HON. GERRY T. PAGLINAWAN, Municipal Mayor of Dumingag, Zamboanga del Sur, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. ESTABLISHMENT AND COMPOSITION.

The Retooled Support Community Program (RSCP) is hereby established in the Municipality of Dumingag, Zamboanga del Sur. It shall be composed of, but not limited to the following:

SECTION 2. OBJECTIVES.

The RSCP shall have the following objectives:

- a. To strengthen community participation in local governance and development;
- b. To improve coordination among government agencies and stakeholders at the community level;
- c. To identify, prioritize, and address the needs of identified support communities; and
- d. To promote sustainable and inclusive local development.

SECTION 3. COVERAGE.

The Program shall cover identified barangays or communities in the Municipality of Dumingag to be determined by the Municipal Government, in coordination with concerned offices and stakeholders.

SECTION 4. IMPLEMENTING OFFICES.

The implementation of the RSCP shall be led by the Municipal Government of Dumingag, through the concerned municipal offices, in coordination with national government agencies, barangay local government units, and other partner institutions.

SECTION 5. ROLES AND RESPONSIBILITIES.

Concerned municipal offices and partner agencies shall:

- a. Provide technical assistance and support to the identified communities;
- b. Participate in planning, implementation, and monitoring activities under the Program; and
- c. Submit periodic reports to the Office of the Municipal Mayor on program accomplishments.

SECTION 6. FUNDING.

Funds necessary for the implementation of this Program shall be sourced from available local funds, subject to existing budgeting, accounting, and auditing rules and regulations, and may be supplemented by funds from other lawful sources.

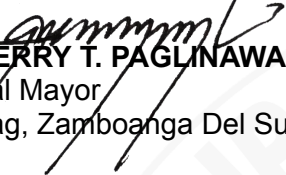
SECTION 7. SEPARABILITY CLAUSE.

If any provision of this Executive Order is declared invalid or unconstitutional, the remaining provisions shall remain in full force and effect.

SECTION 8. EFFECTIVITY.

This Executive Order shall take effect immediately upon signing.
