AN EXECUTIVE ORDER CREATING THE LOCAL INVESTMENT AND INCENTIVES BOARD (LIIB) OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR

WHEREAS, the Municipality of Dumingag recognizes the importance of promoting investments and providing appropriate incentives to encourage economic growth, job generation, and sustainable local development;

WHEREAS, the creation of a Local Investment and Incentives Board is necessary to institutionalize a mechanism for evaluating, recommending, and monitoring investment proposals and incentive packages within the Municipality, consistent with existing laws and policies;

WHEREAS, the Local Government Code of 1991 (Republic Act No. 7160) empowers local chief executives to create committees and boards to assist in the efficient discharge of their functions;

NOW, THEREFORE, I, HON. GERRY T. PAGLINAWAN, Municipal Mayor of Dumingag, Zamboanga del Sur, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. CREATION OF THE LOCAL INVESTMENT AND INCENTIVES BOARD.

There is hereby created a Local Investment and Incentives Board (LIIB) in the Municipality of Dumingag, Zamboanga del Sur.

SECTION 2. Composition.

The Local Investment and Incentives Board shall be composed of the following:

SECTION 3. Functions and Responsibilities.

The Local Investment and Incentives Board shall have the following functions:

- a. Formulate and recommend policies, guidelines, and incentive schemes to promote investments in the Municipality;
- b. Evaluate and review investment proposals and applications for incentives;
- c. Recommend to the Sangguniang Bayan the grant of appropriate fiscal and non-fiscal incentives;
- d. Monitor and assess the performance of registered enterprises and incentive recipients; and
- e. Perform such other functions as may be necessary to promote local investments.

SECTION 4. Meetings.

The Board shall meet regularly or as often as necessary, upon call of the Chairperson.

SECTION 5. Funding.

Funds necessary for the operations of the Local Investment and Incentives Board shall be charged against available local funds, subject to existing accounting and auditing rules and regulations.

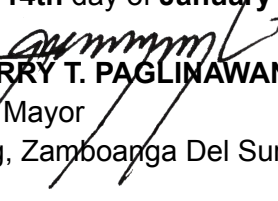
SECTION 6. Separability Clause.

If any provision of this Executive Order is declared invalid or unconstitutional, the remaining provisions shall remain in full force and effect.

SECTION 7. Effectivity.

This Executive Order shall take effect immediately upon signing.
