AN EXECUTIVE ORDER CREATING THE MUNICIPAL TOURISM COUNCIL (MTC) OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR

WHEREAS, tourism is a vital driver of local economic growth, employment, and cultural promotion, and plays an important role in sustainable development;

WHEREAS, Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes the Local Chief Executive to create councils, committees, and other bodies to assist in governance and development planning;

WHEREAS, there is a need to institutionalize a Municipal Tourism Council that shall serve as an advisory and coordinating body in the planning, development, promotion, and regulation of tourism-related activities in the Municipality of Dumingag;

NOW, THEREFORE, I, HON. GERRY T. PAGLINAWAN, Municipal Mayor of Dumingag, Zamboanga del Sur, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. CREATION OF THE MUNICIPAL TOURISM COUNCIL.

There is hereby created a Municipal Tourism Council (MTC) of the Municipality of Dumingag, Zamboanga del Sur.

SECTION 2. COMPOSITION.

The Municipal Tourism Council shall be composed of the following:

SECTION 3. FUNCTIONS AND RESPONSIBILITIES.

The Municipal Tourism Council shall have the following functions:

- a. Formulate and recommend policies, plans, and programs for tourism development in the Municipality;
- b. Assist in the promotion and marketing of local tourism destinations, products, and events;
- c. Coordinate with national government agencies, private sector, and other stakeholders on tourism-related activities;
- d. Recommend measures for the protection, preservation, and sustainable use of tourism sites;
- e. Monitor and evaluate tourism programs and projects implemented in the Municipality; and
- f. Perform such other functions as may be necessary to advance local tourism development.

SECTION 4. MEETINGS.

The Council shall meet regularly or as often as may be necessary upon call of the Chairperson.

SECTION 5. FUNDINGS.

Funds necessary for the operations of the Municipal Tourism Council shall be charged against available local funds, subject to existing accounting and auditing rules and regulations.

SECTION 6. SEPARABILITY CLAUSE.

If any provision of this Executive Order is declared invalid or unconstitutional, the remaining provisions shall remain in full force and effect.

SECTION 7. EFFECTIVITY CLAUSE.

This Executive Order shall take effect immediately upon signing hereof and shall remain in full force and effect until revoked, rescinded, amended or superseded.
