AN EXECUTIVE ORDER ON THE REORGANIZATION OF THE MUNICIPAL SCHOOL BOARD (MSB) OF THE MUNICIPALITY OF DUMINGAG

WHEREAS, Section 98, RA 7160, otherwise known as the Local Government Code of 1991, provides that there shall be established in every province, city or municipality a provincial, city or municipal school board;

WHEREAS, RA 7160, Local Government Code of 1991 provides for the composition of the Municipal School Board (MSB);

NOW THEREFORE, I, GERRY T. PAGLINAWAN, Mayor of the Municipality of Dumingag, by virtue of the powers vested in me by law, do hereby order the adaptation of the reorganization of the Municipal School Board (MSB) of the Municipality of Dumingag:

SECTION 1. COMPOSITION.

The Municipal School Board (MSB) shall be composed of, but not limited to the following:

SECTION 3. FUNCTIONS.

The Municipal School Board's primary duties and responsibilities includes, but are not limited to:

1. Determine, in accordance with criteria set by the Department of Education, the annual supplemental budgetary needs for the operation and maintenance of public schools within the municipality, and the supplementary local cost of meeting such needs, which shall be reflected in the form of an annual budget corresponding to its share of the proceeds of the special levy on real property constituting the Special Education Fund and such other sources of revenues as laws and ordinances may provide;
2. Authorize the Municipal Treasurer to disburse funds from the Special Education Fund pursuant to the budget prepared and in accordance with existing rules and regulations;
3. Serves as advisory committee to the Sanggunian concerned on educational matters such as but not limited to, the necessity for and the uses of local appropriations for educational purposes;
4. Recommend changes in the names of public schools within the territorial jurisdiction of the LGU for enactment by the Sangguniang concerned.

SECTION 4. MEETING.

The Municipal School Board (MSB) shall meet at least once a month or as often as necessary. Only the regular members of the MSB shall be counted in determining quorum and shall exercise voting powers. Expanded members may participate in the meetings in an advisory capacity but shall not have voting rights nor be counted in the determination of quorum. Representatives from the academe may be invited to attend MSB meetings, provided that prior notice is given to the MSB Secretariat.

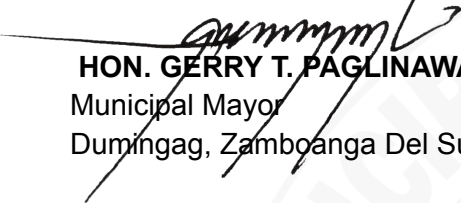
SECTION 5. SEPARABILITY.

Any part of this order inconsistent with the existing laws shall be automatically revoked, remaining parts shall remain enforceable.

SECTION 6. EFFECTIVITY CLAUSE.

This Executive Order shall take effect immediately upon signing hereof and shall remain in full force and effect until revoked, rescinded, amended or superseded.
