AN EXECUTIVE ORDER RECONSTITUTING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) OF THE MUNICIPALITY OF DUMINGAG

WHEREAS, section 16 of Republic Act (RA) 7160, otherwise known as the Local Government Code of 1991 mandates that Local Government Units (LGUs) shall, within their territorial jurisdictions, promote health and safety, improve public morals, maintain peace and order and preserve the comfort and convenience of the people;

WHEREAS, the proliferation and use of illegal drugs slow down overall efforts aimed to promoting productive family life, community peace and harmony and ultimately nation building and national development;

WHEREAS, national government efforts in controlling illegal drugs should be properly coordinated by the Local Government Units (LGUs) to ensure harmonious relationship into the campaign of illegal drugs;

WHEREAS, it is necessary to reorganize the Municipal Anti-Drug Abuse Council (MADAC) to effectively implement the plans and programs for the current and upcoming years.

NOW THEREFORE, I, GERRY T. PAGLINAWAN, Mayor of the Municipality of Dumingag, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Municipal Anti-Drug Abuse Council (MADAC) of the Municipality of Dumingag.

SECTION 1. COMPOSITION.

The Municipal Anti-Drug Abuse Council (MADAC) shall be composed of, but not limited to the following:

SECTION 2. FUNCTIONS.

The Municipal Anti-Drug Abuse Council (MADAC) primary duties and responsibilities includes, but are not limited to:

1. Serve as the focal point through which various organizations and individuals work together in planning, implementation, and evaluation of programs on drug abuse prevention.
2. Provide effective means for coordination of existing services and programs that could be developed in the future.
3. Provide means to obtain funds, volunteer facilities, and technical expertise;

4. Conduct information and education campaign on the ill-effect of illegal drugs monitor and report to proper authorities drug pushers and drug-users in their locality;
5. Prepare a confidential watch list of drug users and pushers found in the LGU area of jurisdiction to be submitted to the PNP Anti-illegal Drug Task Force for the latter's validation or verification leading to the arrest and filing of appropriate charges and;
6. Perform other related responsibilities as may be assigned by competent authorities.

SECTION 3. MEETING.

The Council shall meet at least once every first Thursday of the First Month of the Quarter, or as often as necessary to improve and deliberate on vital matters pertaining to the anti-drug abuse status of the municipality.

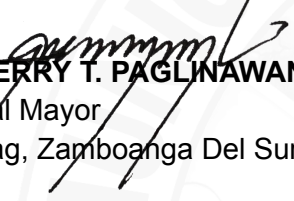
SECTION 4. SEPARABILITY.

Any part of this order inconsistent with the existing laws shall be automatically revoked, remaining parts shall remain enforceable.

SECTION 5. EFFECTIVITY CLAUSE

This Executive Order shall take effect immediately upon signing hereof and shall remain in full force and effect until revoked, rescinded, amended or superseded.
