EXECUTIVE ORDER NO. 34

AN EXECUTIVE ORDER RECONSTITUTING THE MUNICIPAL AGRICULTURE AND FISHERIES DEVELOPMENT COUNCIL (MAFDC) IN THE MUNICIPALITY OF DUMINGAG.

WHEREAS, Executive Order 116, s. 1987 dates the replication of the National Agricultural and Fishery Council in the regions, provinces, cities, municipalities and barangays;

WHEREAS, the Municipal Agriculture and Fisheries Development Council (MAFDC) will serve as an advisory monitoring and evaluating body and a linkage of the Department of Agriculture with the Local Government Units (LGUs);

WHEREAS, the MAFDC will provide an avenue for consultative and continuing discussions within the agricultural and fishery secretary of the national economy.

NOW THEREFORE, I, **GERRY T. PAGLINAWAN**, Mayor of the Municipality of Dumingag, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Municipal Agriculture and Fisheries Development Council (MAFDC) of the Municipality of Dumingag.

SECTION 1. COMPOSITION.

The Municipal Agriculture and Fisheries Development Council (MAFDC) shall be composed of, but not limited to the following:

SECTION 2. FUNCTIONS.

The Municipal Agriculture and Fisheries Development Council (MAFDC), shall exercise the following functions, to wit:

1. Identify and assess the diverse needs and resources of the area in consultation with government and non-government organizations (NGOs) in order to bring about a collective effort in agricultural and rural development;
2. Participate in policy assessment and formulation, planning of programs and projects to meet the identified needs in agriculture, fishery, agribusiness and related activities;
3. Assist in the preparation of the Municipal Agriculture Development Plan and submit it to the Municipal Development Council;
4. Implement the approved Municipal Agriculture Development Plan and assist in the programs and projects of the Department of Agriculture (DA) and its attached agencies;
5. Conduct regulation consultations/congresses with Barangay Fishery and Aquatic Councils (BFACs) and other various interested groups to identify opportunities available and to address problem/issues affecting agricultural development in the area;
6. Conduct regular and special meetings to update members on latest issuances, policies, updates and issues concerning agriculture & fishery;
7. Recommend the enactment of municipal agriculture and fisheries ordinances to the Sangguniang Bayan through its Committee on Agriculture and Cooperatives;

8. To source out/raise funds for the implementation of programs, projects and activities of the Council;
9. To promote capability building activities for MAFDC officers and BFAC officers and members.

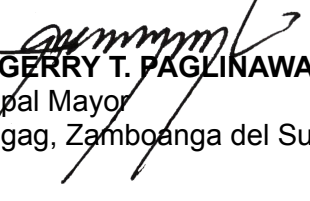
SECTION 3. REPEALING CLAUSE.
