AN EXECUTIVE ORDER ON THE RECONSTITUTION OF THE MUNICIPAL FINANCE COMMITTEE (MFC) OF THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR.

WHEREAS, Republic Act No. 7160 otherwise known as the Local Government Code 1991 provided for the creation of the Municipal Finance Committee in every local government unit;

WHEREAS, as provided for under Chapter 3, Article 1, Section 316 of Republic Act 2160, every local government is mandated to create its Municipal Finance Committee composed of the local planning and development officer, the local budget officer and the local treasurer;

WHEREAS, the Local Chief Executive may designate other members of the Municipal Finance Committee, who could help in the effective and efficient execution of its functions;

NOW THEREFORE, I, GERRY T. PAGLINAWAN, Mayor of the Municipality of Dumingag, by virtue of the powers vested in me by law, do hereby order the adaptation of the reconstitution of the Municipal Finance Committee (MFC) of the Municipality of Dumingag.

SECTION 1. COMPOSITION.

The Municipal Finance Committee (MFC) shall be composed of, but not limited to the following:

SECTION 2. EXPANDED MUNICIPAL FINANCE COMMITTEE COMPOSITION.

4. **REINA VASQUEZ**, *Municipal Accountant*
5. **JANICE MAE D. PAGLINAWAN**, *Municipal Administrator*

SECTION 3. FUNCTIONS.

The Municipal Finance Committee (MFC) primary duties and responsibilities includes, but are not limited to:

1. Determine the income reasonably projected as collectible for the ensuing fiscal year;
2. Recommend the appropriate tax and other revenue measures or borrowings which may be appropriated to support the budget;
3. Recommend to the Municipal Mayor the level of the annual expenditures and the ceiling of spending for economic, social and general services based on the approved local development plans;
4. Recommend to the Municipal Mayor the proper allocation of expenditures for each development activity current operating expenditures and capital outlays;
5. Recommend to the Municipal Mayor the amount to be allocated for capital outlay under each development activity infrastructure project;
6. Conduct semi-annual review and general examination of cost and accomplishments against performance standards applied in undertaking development projects and prepare a report in connection therewith.

SECTION 4. SEPARABILITY.

Any part of this order inconsistent with the existing laws shall be automatically revoked, remaining parts shall remain enforceable.

SECTION 5. EFFECTIVITY CLAUSE.

This Executive Order shall take effect immediately upon signing hereof and shall remain in full force and effect until revoked, rescinded, amended or superseded.
