AN EXECUTIVE ORDER CREATING THE MUNICIPAL MEASLES–RUBELLA SUPPLEMENTAL IMMUNIZATION ACTIVITY (MR SIA) TASK FORCE AND DIRECTING THE IMPLEMENTATION OF THE MR SIA IN THE MUNICIPALITY OF DUMINGAG, ZAMBOANGA DEL SUR

WHEREAS, measles and rubella are highly contagious viral diseases that pose serious health risks, particularly to children, and may lead to severe complications and death;

WHEREAS, the Department of Health (DOH) has mandated the conduct of the Measles–Rubella Supplemental Immunization Activity (MR SIA) to increase population immunity and prevent outbreaks;

WHEREAS, the Local Government Unit plays a vital role in ensuring the successful planning, implementation, and monitoring of public health programs such as the MR SIA;

WHEREAS, there is a need to mobilize all concerned offices, barangays, and stakeholders to ensure effective and efficient implementation of the MR SIA in the Municipality of Dumalinao;

NOW, THEREFORE, I GERRY T. PAGLINAWAN, Mayor of the Municipality of Dumingag, by virtue of the powers vested in me by law, do hereby order the creation of the Municipal Measles-Rubella Supplemental Immunization Activity (MR SIA) Task Force of the Municipality of Dumingag:

SECTION 1. CREATION OF THE MR SIA TASK FORCE.

There is hereby created the Municipal MR SIA Task Force that shall oversee the planning, implementation, coordination, and monitoring of the Measles–Rubella Supplemental Immunization Activity (MR SIA) in all barangays of the Municipality of Dumalinao, Province of Zamboanga del Sur, for the implementation period of January 19 to February 13, 2026.

SECTION 2. COMPOSITION OF THE MR SIA TASK FORCE.

The MR SIA Task Force shall be composed of the following:

SECTION 3. FUNCTIONS OF THE MR SIA TASK FORCE.

The MR SIA Task Force shall have the following functions:

- a. Ensure effective planning and coordination of MR SIA activities;
- b. Mobilize human resources, logistics, and other support necessary for the successful implementation of MR SIA;
- c. Conduct advocacy, social mobilization, and information campaigns to increase public awareness and acceptance of MR SIA;
- d. Ensure the participation of all barangays, schools, and partner agencies;
- e. Monitor and evaluate the implementation and coverage of MR SIA activities;

f. Address issues, concerns, and challenges encountered during the implementation of MR SIA.

SECTION 4. ROLES OF BARANGAYS.

All Barangay Captains are hereby directed to actively support and participate in the conduct of MR SIA, including mobilization of barangay health workers, volunteers, and target beneficiaries within their respective jurisdictions.

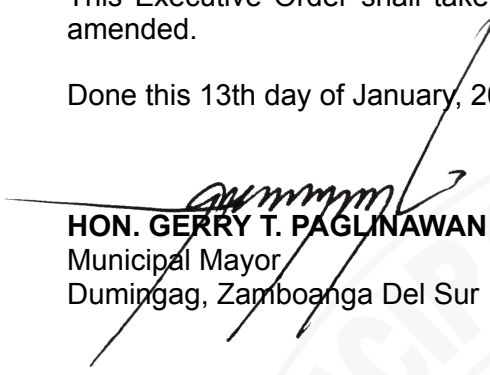
SECTION 5. FUNDING.

Funds necessary for the implementation of this Executive Order shall be charged against available local funds, subject to existing accounting and auditing rules and regulations, and supplemented by national government and partner agency support when applicable.

SECTION 6. EFFECTIVITY.

This Executive Order shall take effect immediately upon signing and shall remain in force until revoked or amended.
